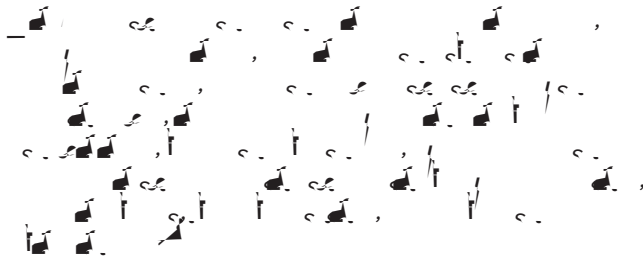

Section Five: Professional Considerations

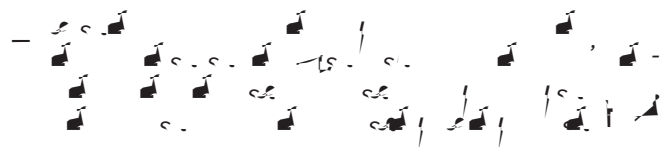
Business Relationships

When a professional is in a business relationship with a client, the professional must maintain the highest level of integrity and honesty. This includes being transparent about any conflicts of interest and ensuring that the client's best interests are always the primary concern. The professional should also be clear about the terms of the relationship, including any fees or compensation, and should avoid any actions that could be perceived as a breach of trust.

1. The professional should always be honest and transparent with the client. This includes disclosing any potential conflicts of interest and ensuring that the client understands the nature of the relationship and any associated costs.

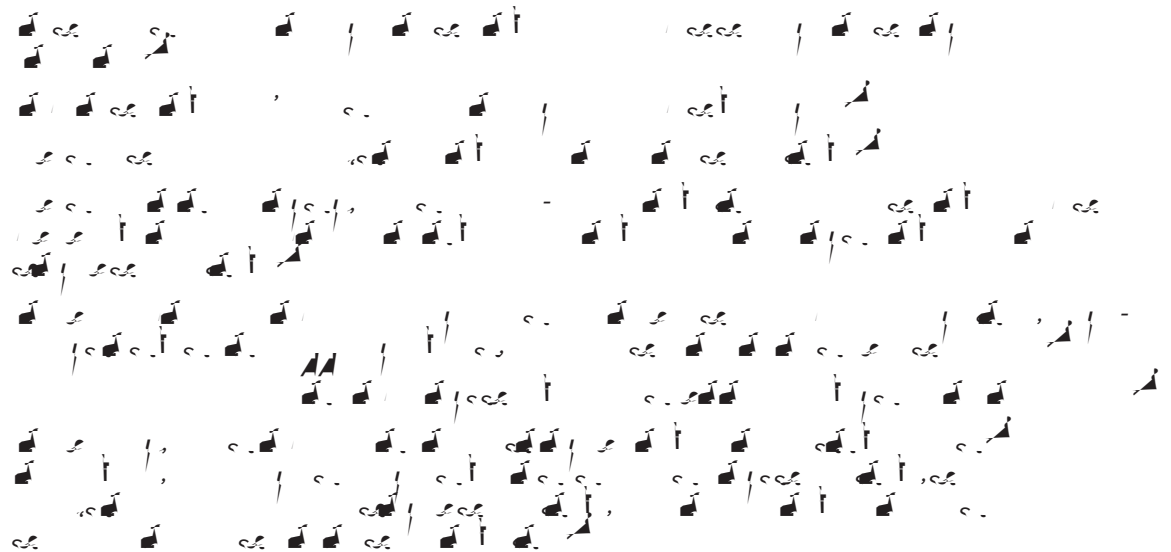
2. The professional should always act in the best interests of the client. This means avoiding any actions that could be perceived as a breach of trust or that could harm the client.
